CBS 100 Comm. & Behavioral Sci. Special Topics (1-4) 1,0

Designed to satisfy needs or interests for the Communication and Behavioral Sciences (CABS) disciplines. This course may be offered to meet the interests of a group of students, study a current problem, or meet similar educational situations. Course is repeatable to 12 credits. Proficiency Credit: Not Available Pass/No Credit: Not Available.

Students will collaborate to engage in secondary and primary research in order to assume leadership roles in service projects connected to addressing the issue being researched. CBS 151 Honors Capstone Portfolio (1) 1,0

This course is designed to support Honors Program students in the completion of their Honors Capstone Portfolio. Completion of the Capstone Portfolio independent study project is one of the requirements to become an Honors Program Graduate or Honors Program Achiever. The creation of the portfolio will ask students to review their Honors experiences inside and outside the classroom in order to thoughtfully reflect on how the selected artifacts meet each Honors Program outcome. If jury examination is chosen, students need to attend at least one student recital in addition to the 7 campus performances. This course is repeatable 3 times. Students are required to perform at the end of the course in an ECC-organized recital and a jury examination. Course is repeatable up to a maximum of six college credit Proficiency Credit: Available (2 EIS) Pass/No Credit: Available.
